This family oriented outdoor festival will welcome over 35,000 festival goers. Held in Vinton, the festival is partnering with strategic area businesses, media outlets and local entertainment to guarantee an outstanding venue.

We hope you will consider becoming one of our concessionaires for this 2010 event. Our aim is to offer a vast menu of food at a fair value. During the selection process, we will look for concessionaires who provide one or more of the following: the traditional festival fare, a more health conscious menu, and unique specialty items.

Concessionaire fees are \$250 per booth for professional vendors or \$40 for non-profit/civic groups. No refunds for inclement weather. No roving sales.

TO BE CONSIDERED FOR THE EVENT YOU MUST:

- 1) Meet Roanoke County Health Department guidelines and obtain permit; a fee of \$25 is charged by Roanoke County this year for professional vendors. \$50 if 10 days or less prior to event date.
- 2) Obtain permit from the Vinton Dogwood Festival as a qualified food vendor
- 3) Adhere to Roanoke County's Fire Prevention Code.
- 4) Provide own silent power source.

Once you've completed the application portion, return it with payment to the Concessionaire Director's attention at the Festival's address, P.O. Box 384 Vinton, VA 24179. All payments will be by either cash or certified check only.
